- b) Dr. Brown proudly announced Bamberg County School District's 2024-2025 school level teachers of the year: Allison Harper for Richard Carroll Elementary School, Monica Harley for Bamberg-Ehrhardt Middle School, Heather Palmer for Bamberg-Ehrhardt High School, Wanda Summers for Denmark-Olar Elementary School, Teresa Rivers Johnson for Denmark-Olar Middle School, and Phillip Robinson for Denmark-Olar High School. Dr. Brown advised they were chosen by their peers and all would now compete for Bamberg County School District's 2024-2025 District Teacher of the Year.
