Sealed proposals will be received by Board of School Commissioners of Mobile County, Alabama at its Facilities Department Front Desk, Building F, 1 Magnum Pass, Mobile, Alabama 36618, until **2:00 PM on Tuesday, November 5th, 2024**, at which time and place they will be publicly opened and read. A cashier's check or bid bond payable to Board of School Commissioners of Mobile County, Alabama in an amount not less than five (5) percent of the amount of the bid, but in no event more than \$10,000, must accompany the bidder's proposal. Performance and Payment Bonds and evidence of insurance required in the bid documents will be required at the signing of the Contract. A Mandatory Prebid Meeting will be held in the Facilities Conference Room, Building F, 1 Magnum Pass, Mobile, Alabama 36618 at **10:00 AM on Tuesday, October 29th, 2024**. Drawings and specifications may be examined at the office of Watermark Design Group, 2970 Cottage Hill Road, Suite #200, Mobile, Al 36606, (251) 344-5515, the Facilities Department, Building F, 1 Magnum Pass, Mobile, Alabama 36618, Bid Documents (hardcopy and digital) may be obtained from the Architect. Hardcopy requires a deposit of \$50.00 per set. Deposit will be refunded in full on the first set issued to each General Contractor submitting a bona fide bid and provided the documents are returned in good condition within ten days of bid date. Digital copies require execution of an Agreement to Release and Transfer Electronic Files. Other sets for General Contractors, and sets for subcontractors and suppliers, may be obtained with the same deposit, which will be refunded as above, less cost of printing, reproduction, handling, and distribution. Bids must be submitted on proposal forms furnished by the Architect or copies thereof. All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, and must show evidence of license before bidding or bid will not be received or considered by the Architect; the bidder shall show such evidence by clearly displaying his or her current license number on the outside of the sealed envelope in which the proposal is delivered. The Owner reserves the right to reject any or all proposals and to waive technical errors if, in the Owner's judgement, the best interests of the Owner will thereby be promoted.
