A. ANNUAL TITLE I MEETING

North Forrest Elementary will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school’s Title I program, the nature of the Title I program, the parents’ requirements, the school parental involvement policy, the schoolwide plan, and the school-parent compact.

There will be an annual Title I Meeting held in the month of August or September.

B. FLEXIBLE NUMBER OF MEETINGS

North Forrest Elementary will offer a flexible number of engagement meetings at convenient times for families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parental involvement).

Information related to the school and parent programs, meetings, and other activities, will be sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand

The policy is distributed to parents during Registration, Meet the Teacher, Open House, and at the Annual Title I Meeting. Additionally, the policy is available on the school webpage.

The school provides information related to school and parent programs, meetings, students' expected proficiency levels, curriculum used, forms of assessment and other activities to parents in a practical parent friendly language/format at the annual Title I meeting and through parent flyers, progress reports/report cards quarterly, (STAR, NWEA, MAAP) assessment reports after each testing window, Making Data Matter quarterly, and face-to-face explanation of score reports during conferences, Moms Muffins Measures, Dads Doughnuts Data, or Parents Pastries Performance.

E. DISSENSION PROCESS

North Forrest Elementary will submit any comments/concerns to the Forrest County School District Superintendent if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents.

F. SCHOOL-PARENT COMPACT

North Forrest Elementary will take the following actions to jointly develop with parents of participating children a school-parent compact that outline how families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

The parents, teachers, and students jointly develop the school-parent compact. It is reviewed and updated by way of completing title surveys and participation in spring/summer planning/ parent advisory meetings. The compact is distributed to parents during registration, Meet the Teacher, Open House, and reviewed at the Annual Title I Meeting. Additionally, the compact is available on the school webpage. It is used at parent/teacher/principal conferences and within the daily management of the classroom.

G. BUILD CAPACITY OF PARENTS

North Forrest Elementary will build the parents' capacity for strong parental involvement to ensure effective involvement of parents and families and to support a partnership among the school and the community to improve student academic achievement through the following:

*In addition to progress reports/report cards quarterly, assessment reports after each testing window, Making Data Matter quarterly distribution, and face-to-face explanation of score reports during conferences, Parents Pastries Performance, Moms Muffins Measures, and Dads Doughnuts Data, parent capacity is built through parent academy where parents are educated on assessments and organizational goals. Parents gain knowledge of read-at-home plans for student success, home connection flyers, materials in the parent resource center; resources for parents of exceptional students, and students/family engagement resource pack. **We will conduct face-to-face meetings; however, as the need is determined and circumstances require, virtual meetings via Zoom and/or Google meet may be the first and/or only option for the safety and health of all participants.** This will be done on a case-by-case basis unless otherwise mandated.*

Parents are given access to online resources i.e., Study Island, ExactPath, Online Textbooks (where applicable) so they can readily follow student progress at home. See parent-meeting dates below.

H. ACCESSIBILITY

North Forrest Elementary in carrying out the parent and family engagement requirements of this part, to the extent practicable, shall provide full opportunities, for the participation of parents and family members (including parents and family members with limited English proficiency, parents and family members with disabilities, and parents and family members of migratory children), including providing information and school reports required under section 1111 in a format, and to the extent practicable, in a language such parents understand.

School newsletters, progress reports/report cards quarterly, assessment reports after each testing window, and home connection flyers are distributed in the native language of students of families with limited English. The ELL translator is available. Flyers are made in large print. Home conferences are available to accommodate families. The campus is handicap accessible including parking. Parents are given access to online resources i.e., Active parent, IXL so they can readily follow student progress at home. Parent meeting dates follow.
