The Fannin County Board of Education met in regular session with the following members present: Sandra Mercier, Chair; Steve Stanley, Vice-Chair; Bobby Bearden; Terry Bramlett; and Lewis DeWeese. All members present.

Motion by Terry Bramlett, seconded by Bobby Bearden, to approve the proposal from Atlas Manufacturing, Inc. in the amount of \$29,912.86 for a greenhouse at the middle school to be paid out of SPLOST funds.

Motion by Steve Stanley, seconded by Terry Bramlett, to approve the proposal from American Energy Restaurant Equipment Company in the amount of \$57,581.00 for a Thermo-Kool cooler/freezer to be installed at West Fannin Elementary School to be paid out of SPLOST funds.

Motion by Bobby Bearden, seconded by Terry Bramlett, to approve the following field trip requests:
