The North Canaan Board of Education met in the library at 6:30 pm on Tuesday, May 13, 2025.

**A meeting was held:** Lindsey Crane, Stephannie Grant, Amy Helminiak, Christopher Jacques, and Brooke Riva.

**I. Call to Order**: The meeting was called to order at 6:30 pm by Mr. Jacques.

#### II. Consent Agenda

Superintendent Brady-Shanley provided a brief overview of the Monday, April 7, 2025 Region One Board meeting. Some of the items she reported on are listed below:

#### B. New Hires

#### 1. Hiring of a 2nd grade teacher

Mr. Jacques made a motion to hire Skylar Agar as a 2nd grade teacher for the 2025-2026 school year at a Step 1 Masters with a salary rate of \$53,348. Mrs. Grant seconded. Vote: 5-yes Mrs. Crane, Mrs. Grant, Mrs. Helminiak, Mr. Jacques, and Mrs. Riva.

#### 2. Hiring of a 3rd grade teacher

Mr. Jacques made a motion to hire Stefanie L. Remillard as a 3rd grade teacher for the 2025-2026 school year at a BA 8 with a salary rate of \$66,580.00. Mrs. Grant seconded. Vote: 5-yes Mrs. Crane, Mrs. Grant, Mrs. Helminiak, Mr. Jacques, and Mrs. Riva.

#### C. Approval of Grades 7 and 8 Regional Survey

Mr. Jacques made a motion to approve the Youth Voices Count survey to be administered to grades 7 and 8 students this spring. Mrs. Grant seconded. Vote: 5-yes Mrs. Crane, Mrs. Grant, Mrs. Helminiak, Mr. Jacques, and Mrs. Riva.

#### XI. Administrative Reports

**Principal's Report:** (A copy is available through the links on the May agenda.) Mrs. Johnson provided a brief overview of her report. Some of the items she reported are listed below:

- On Tuesday, April 23rd, Pre-K through 2nd grade students at NCES created posters and cheered on their peers taking the SBAC tests. Older students followed with a spirited chant contest, turning the pep rally into a fun and uplifting event that brought a positive energy to state testing.
- NCES proudly celebrated our 35th annual Arbor Day ceremony. Fifth graders shared original poems, and first grade and Kindergarten students performed songs.

- NCES hosted our annual Arts Night, showcasing student artwork from all grade levels.
   The evening also featured a wonderful choral and band concert, highlighting the talents of our student musicians in grades 4 through 8.
- Mrs. Erickson is promoting reading through the Heifer International Read to Feed program. Students log their pages on the Beanstalk app and not only do they earn cool prizes but help fight world hunger.

**Superintendent's Report:** (A copy is available through the links on the May agenda.) Superintendent Brady-Shanley provided a brief overview of her report. Some of the items she reported are listed below:

- There is a first impact from the changes at the federal level. In each of our schools, there is a .5 FTE social worker/counselor that is grant funded through EdAdvance. Unfortunately, EdAdvance has been notified that this grant will be discontinued effective December 31, 2025. EdAdvance is submitting a request for reconsideration, exploring alternative funding sources, and assessing whether they can support the position internally.
- On May 1, 2025, Dr. Rose and Superintendent Brady-Shanley attended the Troutbeck Symposium. Many Region One schools participated in the event, which highlights the rich history of the Northwest Corner.
- Senior Awards Night is being restructured. The presentation will encourage greater staff
  participation, ensure attendance from all National Honor Society members across all
  grades, and prominently recognize each of our local donors on stage throughout the
  event. The goal is to highlight the generous contributions the community partners make
  to support Region One's students. These gifts are deeply appreciated by both students
  and their families.
