RESOLUTION DESIGNATING DISTRICT'S ELECTION REPRESENTATIVE May 13th, 2025

Onaway, Michigan (The "Onaway Area Community School District")

A regular meeting of the board of education of Onaway Area Community Schools, Onaway Michigan (the "Board"), was held in the Media Center, in the District, on the 13th day of May, 2025, at 7 o'clock in the evening.

The following preamble and resolution were offered by Member Annette Porter and supported by Member Tom Moran.

WHEREAS:

1. The biennial election of the Board of Cheboygan-Otsego-Presque Isle Educational Service District, Michigan (the "ESD Board") will be held on Monday, June 5, 2023; and
2. The members of the ESD Board will be elected by an electoral body composed of 1 person designated by the board of each of the constituent school districts; and
3. In accordance with Section 614(2) of the Revised School Code [MCL 380.614(2)], this Board designates John Kaszonyi as this District's proposed representative and directs said representative to vote on behalf of this Board for a specific candidate.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. This Board does hereby approve the designation of John Kaszonyi as the representative of this Board for the electoral body, which body will elect three (3) candidates to the vacancies on the ESD Board on Monday, June 2, 2025 and Annette Porter as an alternate in the event the designated representative is unable to attend.
2. The designated representative is further directed to cast a vote on the first ballot on behalf of this Board as follows:

Dennis Budnick 6 year Term thru June 2031

Mitchell Hintz 6 year Term thru June 2031

Julie Waldron 6 year Term thru June 2031

3. The Secretary of this Board is hereby further directed to file a certified copy of this resolution with the Secretary of the ESD Board.
4. All resolutions and parts of resolution insofar as they conflict with the provisions of this resolution be and the same are hereby rescinded.

1. Section 624 of the Revised School Code, as amended, requires the intermediate school board to submit its proposed budget not later than May 1 of each year to the board of each constituent district for review; and
2. Not later than June 1 of each year, the board of each constituent district shall review the proposed intermediate school district budget, shall adopt a board resolution expressing its support for or disapproval of the proposed intermediate school district budget, and shall submit to the intermediate school board any specific objections and proposed changes the constituent district board has to the budget.

1. The board of education has received and reviewed the proposed intermediate school district budget in accordance with Section 624 of the Revised School Code, as amended, and by the adoption of this resolution, expresses its support for the proposed intermediate school district budget.


