Voters in North Zulch ISD will vote on a **\$4.5 million** bond on the May 1, 2021 ballot.

Proposed Projects

- ► Renovations to Elementary School and Gym
- ► Classroom addition and security corridor
- Drainage Improvements

Ballot Language Proposition A:

THE ISSUANCE OF NOT TO EXCEED \$4,500,000 OF NORTH ZULCH INDEPENDENT SCHOOL DISTRICT SCHOOL BUILDING BONDS FOR THE PURPOSES OF DESIGNING, CONSTRUCTING, RENOVATING, IMPROVING, UPGRADING, UPDATING, ACQUIRING, AND EQUIPPING SCHOOL FACILITIES, THE PURCHASE OF THE NECESSARY SITES FOR SCHOOL FACILITIES, AND THE PURCHASE OF NEW SCHOOL BUSES, AND THE LEVYING OF A TAX IN PAYMENT THEREOF. THIS IS A PROPERTY TAX INCREASE.

IF THERE IS NO EXPECTED I&S TAX INCREASE, WHY WILL THE BALLOT READ "THIS IS A TAX INCREASE"?

Under Texas law, the voters are not voting on the tax rate, rather the **voters are voting on the issuance of new bonds** for new facility improvements. Therefore, regardless of the tax impact of the new bonds, for the new construction to occur, the law requires that voters must approve the bonds (the financing tool for the construction).

► Maintenance and Operations Taxes (M&O)

- Used to pay for the day-to-day cost of running the district, including salaries, utilities, supplies, and insurance.
- ► Interest & Sinking Taxes (I&S)
- Used to pay for the principal and interest on debt for a specific purpose and term. By law, I&S funds cannot be used to pay M&O expenses. Voterapproved bonds cannot be used to increase teacher salaries or pay rising costs for utilities and services.


