The purpose of this meeting was to discuss the existing Line of Credit for AW BROWN LEADERSHIP ACADEMY. This line of credit was established prior to Superintendent Jefferson's administration. The current payment amount due is estimated @ 882,000. This was based on the enrollment of 2200 scholars, however under the current conditions
