Mr. Kyle Polhill from Benning Group presented a summary of our audit report for fiscal 2023. It was a clean audit with no significant findings or deficiencies.

It is expected that our equalized assessed valuation (EAV) of property in the district will increase 6.88%. In order to capture this growth, we need to conduct a Truth in Taxation Hearing in December. Please note that this is not raising the tax rate and it is important that we capture all of our local revenues due to increasing costs.

Set Board Retreat: A motion was made by T. Hackbarth and seconded by A. Drinkall to set the Board Retreat Date to Wednesday, March 13, 2024 at 5:00 PM at the Milledgeville High School Library. Voice vote showed 7 ayes and no nays. Motion carried.
