What is Title I?

How is it revised?

Sumter County Intermediate School invited all parents to attend our annual Parent Input meeting to review and revise this parent and family engagement policy, as well as the school-wide plan, our school-parent compact, and the family engagement budget. The plan is posted on our school website for parents to view and submit feedback throughout the year. We also distribute an annual survey online and by mail to ask parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year including our annual Stakeholders' Input Meeting.

What is it?

This is a plan that describes how Sumter County Intermediate School will provide opportunities to improve family engagement to support student learning. SCIS values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of improving student achievement. Sumter County Intermediate School will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. We will:

- * Ensure that all information related to school and parent programs, meetings, and other activities is published in both English and Spanish, posted on the school website, and included in the monthly school newsletter for all families.
- * Provide quarterly trainings for staff during their planning periods on strategies to improve communication with parents and ideas to increase family engagement with reading and math activities for our students outside of the classroom. - * Share information in English and Spanish in the school newsletter for parents to understand the school's academic standards and assessments as well as the ways parents can monitor their child's progress and work with educators.
- * Communicate with all families and the community on a regular basis regarding school-wide events and activities, through phone messages, social media, and flyers.
- * Work with our parents to develop relevant trainings and helpful presentations to educate our staff on the importance of parent and family engagement and how to support student learning.
