III Approval of Agenda

Mr. Ryan Hoffman moved with a second by Dr. Jamie Burkhart to approve the consent agenda as presented - payment of bills for \$248,773.64 (check nos 150830-150936), open minutes from April 17, 2025, and financials. Motion carried 7-0.

VI Administrative Reports

Mr. Wells and Mr. Goosen were present to answer questions. Additionally, Mr. Mayes was in attendance to address any inquiries. Mrs. Bowers was absent from the meeting. All board reports have been compiled in the board packet, which can be accessed on the district website.

Mr. Hunter updated the board on the following:

- ~Graduation will be held Sunday, May 18, 2025, at 2:00 pm.
- ~Last day of school is May 21, 2025.
- ~Summer school begins May 28, 2025, and will continue through June 13, 2025.

- ~The paperwork for the Summer Food Service Program has been finalized. Meals will be distributed every Thursday, beginning June 19, 2025, and continuing through August 7, 2025. Meal distribution will take place at the circle drive of the elementary school.
- ~Tax levy ballot issue the Johnson County judge has not made a ruling at this time, citing concerns about equal protection. The earliest this issue could return to the ballot is in November.

VII New Business

A. Gerding, Korte, & Chitwood Audit Service Agreement

Mr. Hunter presented the contract from Gerding, Korte, & Chitwood CPAs for the fiscal year ending June 30, 2025. Dr. Jamie Burkhart moved with a second by Mr. Scott Swigert to approve Gerding, Korte, & Chitwood for the preparation of the audit report for the Henry County R-1 School District for the year ending on June 30, 2025. Motion carried 7-0.

B. Salary Schedules for Certified, Classified, Administration

Mr. Hunter recommended the following certified salary recommendations for approval for the 2025-2026 school year:

- ~ Add \$2490 to the base and utilize the Teacher Baseline Salary Grant
- ~Add \$2000 to BS Step 6
- ~Add \$2000 to BS+8 Step 5
- ~Add \$2000 to BS+16 Step 4
- ~Add \$2000 to BS+24 Step 3
- ~Add \$2000 to MS, MS+8, MS+16, and the Specialist column

Dr. Jamie Burkhart moved with a second by Mr. Jake Drenon to approve the above-listed salary recommendations. The motion carried 7-0.

Mr. Hunter recommended adding 2% to the base of the Classified Salary. Dr. Jamie Burkhart moved with a second by Mr. Scott Swigert to approve the 2% increase to the base of the classified salary. Motion carried 7-0.

Mr. Hunter recommended adding 2% to the base of the Administrative Salary. Dr. Jamie Burkhart moved with a second by Mr. Ryan Hoffman to approve the 2% increase to the base of the administrative salary. Motion carried 6-1.

VIII Approval of Executive Session

Dr. Jamie Burkhart moved with a second by Mr. Scott Swigert to enter executive session for consideration of matters relating to personnel with discussion, record, and vote of the meeting closed in accordance with 610.021 (3) of Missouri Statutes.
