Mountain Vista Athletics Participation Requirements

To participate in Mountain Vista Athletics, the following forms and documents must be completed and submitted before participation.

1. Mountain Vista Athletics Emergency Information and Medical Release Form

This form must be completed for **each sport** in which your child participates to ensure that we have the most current emergency contact and medical information on file. Please scan the QR code provided and complete the form online.

3. 2026 Annual Participation Physical Evaluation

Completed physical forms must be submitted to **Shannon Soulé, Athletic Director**, before a student may participate in practices or competitions. Students who do not have a current physical on file will not be permitted to attend practice.

ACTIVITY TRANSPORTATION GUIDELINE FORM**

Concerning transportation of interscholastic students, the philosophy of the Oracle Elementary School District is that as a member of an interscholastic team, individuals should be transported to and from "AWAY" events or "OFF CAMPUS" practice sites via transportation provided by the school.

PARTICIPANTS IN INTERSCHOLASTIC PROGRAMS AT MT. VISTA K-8 SCHOOL ARE NOT PERMITTED TO TRANSPORT THEMSELVES TO "AWAY CONTESTS" OR "OFF" CAMPUS PRACTICES. However, situations do arise where parents/guardians find it necessary to transport student-athletes to their homes after an "OFF-SITE" practice or contest. The following form has been developed to address these unique transportation needs and document that appropriate communications have taken place between student-athletes, parent/guardians, coaching staff and the site.

PARENTAL CONSENT TO STUDENT TRAVEL IN PRIVATE VEHICLE (S). The undersigned parent/guardian ("the Guardian") permits the student listed below to travel to and/or from the school activity listed below in the personal vehicle of the adult(s) listed below. The Guardian acknowledges that the Oracle Elementary School District ("the District") is not responsible for any accidents or injuries that may occur while the listed student is in the care of and is being transported by the listed adult. The Guardian assumes all responsibility for his/her choice to allow a private individual to transport the listed student. The Guardian agrees to hold the district, its officers, and its employees harmless from any claims arising from or relating in any way to the Guardian's decision to permit the student to travel in the listed adult's private vehicle rather than traveling in a District vehicle. The Guardian hereby waives all claims, whether known or unknown, against the District or its officers and employees for any harm or injury which may occur to the student arising out of the travel authorized by this consent.
