Mrs. Alesia Grimsley was also recognized.

## 11. EDUCATIONAL ITEMS BY THE SUPERINTENDENT

Mr. Key stated that Crossroad Academy Charter School Boys Basketball Team was playing in the State Final Four on Friday (March 1<sup>st</sup>). He stated that if they win the game Friday, they would advance to play for the championship on Saturday (March 2<sup>nd</sup>). He thanked the staff and principal (Ms. Camry Floyd) of Chattahoochee Elementary School; and Dr. Kisha Jarrett along with one of the teachers at James A. Shanks Middle School for attending the meeting. He stated that he met with the Department of Education regarding the district's fund balance. He stated that the Board needed to discuss the district's fund balance because it is decreasing. He stated that Havana Magnet School and Gadsden County High School received a letter grade of "C". He stated that James A. Shanks Middle School letter grade of "I" was not challenged because not enough students were tested. He stated that the district received a letter grade of "C". He stated that the graduation rate is higher than during pre-COVID. He stated that there is still a lot of work to be done such as cleaning up data. He stated that Ms. Caroline McKinnon has returned to the district. He stated that she brings a lot of experience to the assessment department.

## 12. SCHOOL BOARD REQUESTS AND CONCERNS

Ms. Johnson recognized the Special Olympic Athletes in the district. She stated that students would be participating in Special Olympic Games on Saturday, March  $2^{nd}$ . She stated that she would be coaching basketball. She stated that the Board needed to review the Proximity Program information. She stated that she shared the information with the Board at a previous meeting.

Mr. Scott shared the achievements and successes of the late Coach Robert L. Jackson. He stated that Coach Jackson was a great mentor to the students of Gadsden County. He made a motion to name the football field at Greensboro Elementary School the Robert L. Jackson Football Field in honor of his hard work. The motion was seconded by Mrs. Karema D. Dudley and carried unanimously.

Mr. Frost stated that the district needed to start recruiting students to return to the district. Mrs. Dudley stated that education is a business and parents want the best education for their students. She stated that we have to listen to our students. She stated that we live in a global society.

Mrs. Dudley made a motion to schedule a retreat for Board members to review and discuss the district's 5-year strategic plan. The motion was seconded by Ms. Cathy S. Johnson and carried with Ms. Johnson, Mr. McMillan, Mr. Scott and Mrs. Dudley voting "aye". Mr. Frost voted "nay".

Mrs. Dudley reminded the Board of Master Board Training on Thursday, March 14<sup>th</sup> beginning at 9:00 a.m. The Board scheduled a workshop on Thursday, March 14<sup>th</sup> at 3:00 p.m. to discuss the new K-8 school.
