If a child is reported with but not the parent: 1. Explain why child is not with parent. 2. Give residence of parent. 3. Give residence of parent. If living. Census of married people of either sex, who are of school age, shall be taken in district where husband resides. Names will be canceled if these explanations are not made.

Give ages of children as they are May 31, 1923. If a child moves from the district during the fifteen days preceding June 1, he should be enrolled in district where he is resident May 31, 1923.

Be sure that every name, age, date of birth if necessary, and full name of parent is given. The omission of one of these items may cost the district at least ten dollars, when the primary apportionment is made.
