INVITATION TO BID Transportation Fuel (2023-4)

Sealed bids will be received by the Escambia County Board of Education to purchase gasoline and diesel for various locations in the county for the period of October 1, 2023 - September 30, 2024 with the option of an extension of the bid contract for a maximum of five (5) years. The bid extension is renewable each year and is dependent upon the mutual consent of both parties.

Unleaded gasoline (87 octane (E10) or better) and diesel (Ultra Low Sulfur) will be supplied to the following locations for the Escambia County Board of Education: East Brewton Bus Shop, Atmore Bus Shop and Flomaton Elementary School.

The successful bidder will provide metering capability at all delivery locations to confirm the quantity delivered. The metering capability may be in the form of metering gauges on the delivery trucks, through dipping the truck before and after each delivery, or other acceptable method of measurement.

The fuel supply will not be divided among different vendors for unleaded and diesel. In the event of over and under bids primary consideration will be given to the price of the diesel fuel. The contract will be awarded to the vendor best serving the interest of Escambia County schools.

Bid prices are to be effective the **Tuesday** before the date of the bid opening (September 5, 2023). **The OPIS report for September 5, 2023 should be used in determining bid amounts**; thereby, requiring everyone to bid prices for the same day. If prices are not bid firm for the period, bidders will submit bids stating the amount over their supplier's prices they are bidding and will provide a copy of the communication from their supplier showing their prices for the date of the bid opening. The amounts over the supplier should include any and all additional costs such as the storage tank trust fund fee. Prices fluctuating with the market do not constitute a firm bid and would require the successful bidder to supply copies of communications from their supplier confirming the price on the day of delivery. This communication could be in the form of OPIS reports, telefax messages, or other written forms of communication. Oral communication does not constitute satisfactory documentation. The copies are to be provided with each delivery.

Price changes will be based on prices of bidder's supplier to the Mobile Terminal as listed in the daily publication *OIL PRICE INFORMATION SERVICE* (OPIS), as published by United Communications Group, 4550 Montgomery Avenue, Suite 700 N., Bethesda, MD 20814-3382. If bidder's supplier is not listed on the Mobile Terminal prices in the OPIS publication then pricing will be based on the average pricing as shown on the OPIS publication for Mobile terminals.

The Escambia County Board of Education is exempt from paying the federal excise taxes on gasoline and diesel fuels. {Motor Fuel Exemption License No. TXR-R008195623}

In the event price increases are not in parity with increases in the public market, Escambia County Board of Education will review the prices and reserves the right to cancel the contract. Escambia County Board of Education reserves the right to reject any and all bids that do not meet specifications or if prices are considered prohibitive.
