### **ACKNOWLEDGEMENT OF PARKING POLICIES**

Vehicles shall be parked only in areas designated by the administration for student parking. A student may be disciplined or lose parking privileges for failing to park in his/her designated space or for breaking school parking lot rules. I acknowledge that I have read the parking regulations and agree to abide by the regulations. I also understand that my driving privileges and parking permit can be revoked without a refund for violations of the parking regulations or as a result of Code of Conduct violations such as, but not limited to, leaving school without permission (alone or with another person). No decal will be replaced unless the old one, or what remains of it, is brought to the front office. Vehicles parked on school property are under the jurisdiction of the school. The school reserves the right to search any vehicle if reasonable suspicion is presented. Students have full responsibility for the security of their vehicles and will make certain they are locked and that their keys are not given to others. Students will be held responsible for any prohibited objects or substances, such as alcohol, drugs, and weapons that are found in their vehicles and are subject to disciplinary action. Searches of vehicles may be conducted at any time when reasonable suspicion is presented. For safety reasons, student drivers may not enter the parking areas prior to 7:30, unless otherwise communicated by administration, and no later than the 7:44 a.m. bell. Speed limit on campus is 10 mph. Violating the speed limit could result in your driving privileges being revoked. The parking areas are completely off limits during the school day without permission from school administrators.
