December 2024 meeting minutes were read and the floor was opened for a motion to accept the minutes. Motion to accept by Mrs. Tiffany Pitre (Parent); seconded by Mrs. Holly Landry (Parent).

**Old business discussed:** MNRI training-Special education teachers, regular education teachers, paraprofessionals, and administrators across the district participated in the training. 3rd annual Special Olympics-PK-2 Special Olympics day at JHS on 1/17/25 and 4th Annual Track and Field day at LAHS on 3/21/25. 2nd annual "An Evening to Sparkle Dance" was held on 4/2/25. Wendy's Partnership for Special Olympics was a success. In September we will have a 5K sponsored by DA, Ms. Lauren Heinen.

**New business discussed:** On May 12th, students will represent JDP Special Olympics at the JDP Sheriff's Special Olympics Torch Run. ESYS-Critical Point-1st-3rd graders that scored well below will receive 4 weeks of intensive reading instruction/remediation. Prek ESYS-last 2 weeks of July 2025 will work on transition to Prek. Topics for parent nights to be held quarterly-ideas: transition resources, FHF presentations of all resources available, Jumpstart/Pathway information for high school students, accommodations/modifications. Will contract with ABA and BCBA's to address behaviors in PK-12.

**Mrs. Donna Babineaux delivered SPED Updates:**

- April Dunn Self-Audit completed on 45 student files in February; all files in compliance.
- First Parent Night held on March 25, 2025, "Understanding the IEP". Approximately 10 in attendance in person and 7 virtually; positive feedback.
- Testing Updates-All LEAP Connect completed in March, high school LEAP complete with test results coming in, and grades 3-8 currently testing with results to be in at the end of July
- Act 422-Promotion to 4th grade-prohibits promotion to fourth grade if a student scores at the lowest level of the literacy screener with exception through a good-cause exemption.

–Good Cause Exemptions for Students with Disabilities-The IEP will drive the decision for exemption to 3rd grade retention based on literacy screener.
