LeFlore will hold an annual Title I Meeting within the first month of school. To assist in providing an opportunity for all parents to attend, two meeting times are held, one in the morning and one in the evening. We will announce the Title I meeting to parents and stakeholders via newsletter, School messenger, flyers, the school website, social media, and the school marquee. The meeting includes information on our 1% set aside, as well as the rights of parents. \$5,430.85 was set aside for parental involvement. Parents agreed to use funds on a parenting center.

LeFlore Magnet High School will offer more choices for parents to attend meetings by hosting a flexible number of meetings at various times during the day. To reach all parents, a variety of formats will be used which will include both formal and informal meetings. Parents are invited to join committees to assist with different tasks held at the school. Parenting funds are used for materials and supplies for parent resources and parent communication.

At that time, parents will receive an overview of the state academic content standards, academic achievement standards, and assessments such as ACT and ACT Work keys. In addition, an explanation will be given regarding Title I, the services that will be offered, and how parents have the right to be involved in their children's education. Immediately after the general Title I meeting, parents will be given the opportunity to visit their child's classroom, meet their child's classroom teachers and learn about individual class assessments and what their role will be in helping their child to succeed.
