Superintendent Report

Teacher Housing:

Final punch-out list has been submitted to the contractor regarding site work. I am meeting with the Centennial manager this week regarding final punch-out items for the Mobil homes on 3 rd street. The duplex will likely be the first finished with expectation of completion by the end of the month. There is a potential major issue with the double-wide which may significantly delay completion. I will discuss this issue with the Construction Manager. The Superintendent house should also be ready by the end of the month.

Campus Projects

Fence repair and replacement project has been completed. I witl schedule an electrician to hook up power to the bus gate. We are still awaiting the delivery of the new swing for the playground.

Bathroom & Locker Room Project

Tile in both bathrooms should be complete by the end of the week and installation of stalls, toilets, sinks, etc. should begin. We think the bathrooms will be complete by the 16th but it will be close. The locker rooms are still a month or two away from completion. The gym floor wilt be cleared of the majority of building material and the floor tarp removed before school starts to allow use of the gym.
