Coosada Elementary School held its annual meeting in September 2022. All parents will be notified of the meeting through Remind, CES Facebook page, digital sign, and website. The parents were invited for an in-person Title 1 Meeting. Following the in- person meeting, invitations for a digital Title 1 Meeting were sent out. Parents that attended (in-person or digitally) were rewarded by their child receiving a GOTCHA. The leadership and staff at Coosada Elementary believe in parental involvement, offering parent meetings in English and Spanish. Parents and teachers connect by phone or Zoom during planning or after school to receive progress reports for the first nine weeks. Parents receive notification in English and Spanish with an interpreter present at the meeting if needed. Next, the annual Title I Meeting is offered to all parents with childcare provided. The annual meeting was also offered online. The Parent Resource Room is open to all parents.

Parents can be involved in planning by serving on the Building Leadership Team. In addition, all parents are given a Title I parent survey in February. The strengths and weaknesses are identified and presented at the Annual Title I meetings. Finally, parents are invited to be involved in the review and improvement of the LEA Consolidated Plan and LEA Parental and Family Engagement Plan presented in the fall.

Coosada Elementary is a school wide Title I school. The funds allocated for parent involvement are used to purchase take home folders for every student. The folders provide daily communication to the parents of important dates.

Parents are presented information about the curriculum and academic assessments through Zoom conferences, parent phone calls, scheduled conferences, Google Classroom, Remind, and newsletters. Parents are informed regularly about grades through PowerSchool, progress reports, and report cards. Finally, information about programs under Title I is presented at the Annual Title I Meeting. We currently have 42 Spanish speaking parents. Dalila Peake, interpreter is at meetings to translate. Dalila Peake is housed at Coosada Elementary School and is available to translate conversations, documents, and newsletters. Trans Act is used for written communication for other languages in the school. MasterWord is used to verbally communicate with parents speaking another language besides Spanish.

The School-Parent Compact was reviewed by the Parent Advisory committee. Changes were made to the compact as indicated by the committee to omit COVID restrictions and program changes. All parents are given a copy of the School-Parent Compact in the Coosada handbook. The compact is explained at the Annual Title I Meeting. The parents are asked to sign the compact signifying their commitment to working in partnership with the school ensuring that their student is successful. The teachers will sign the compact as well as the student. The compacts are filed in the teachers' classrooms and used during parent teacher conferences.

The Continuous Improvement Plan is posted to the Coosada's website. Copies of the plan are available for review in the office. The complaints will be documented on the school level complaint form, then the form will be submitted to the Building Leadership Team at Coosada. The team will review and respond. Revisions will be made if needed.

Room. Children's stories on CD are available in English and Spanish. Finally, Math Day/Night provides parents the opportunity to observe math games and strategies to use at home.

Coosada Elementary will continue to work with the teachers through faculty and grade level meetings in understanding the importance of parental involvement. Teachers communicate with the parents through newsletters, which are translated for non-English speaking parents. Remind 101, the school website and Facebook are used for school information and reminders. Posters have been placed around the school, in English and Spanish, to promote the Parent Resource Room.

Coosada Elementary coordinates parent involvement programs for all Title I parents. Many of the EL parents are actively involved in all parent activities. The district translator's office is located at Coosada. She works with the ESL Coordinator in meeting the needs of the parents.

At the present time, Coosada has 42 students that require information in Spanish.

Information on all school meetings, parent notices, etc. is sent to these children in Spanish. TransAct and the MasterWord are available for other languages.

Coosada Elementary makes every effort to work with parent's requests as related to their involvement in their child's education. For example, the parent surveys indicated parents wanted a calendar of events and reminders. The school will acknowledge those changes in future parent meetings.

Coosada Elementary, to the extent possible, provided opportunities for the participation of parents with limited English proficiency and disabilities. CES currently has 66 "English as a second language" students. All parent notifications, meeting notices, surveys, and other important school information is sent home in Spanish. In addition, a district translator is available to assist in verbal communication with Spanish speaking parents. TransAct provides important documents in over 20 languages for parents that have requested information to be sent home in their native language. Parents are given a Home Language Survey in their native language. The parents indicate on the HLS the language they want information sent home. The HLS is kept in the student's permanent record, in ESL folder, along with I-ELP, and documented on the PHLOTE list when another language is requested. In addition, CES has access to the MasterWord, which interprets information to the parent in the native home language. Finally, every effort is made to accommodate parents with disabilities; CES is a handicapped accessible building. Currently, Coosada Elementary has no migrant students.
