The requirement that in a student crisis situation, the school or law enforcement personnel must make a reasonable attempt to contact a mental health professional who may initiate an involuntary examination pursuant to s. 394.463, F.S., unless the child poses an imminent danger to self or others before initiating an involuntary examination pursuant to s. 394.463, F.S. Such contact may be in person or using telehealth, as defined ins. 456.47, F.S. The mental health professional may be available to the school district either by contracts or interagency agreements with the managing entity, one or more local community behavioral health providers, the local mobile response team, or be a direct or contracted school district employee. Note: All initiated involuntary examinations located on school grounds, on school transportation or at a school sponsored activity must be documented in the Involuntary Examinations and Restraint and Seclusion (IERS) platform.

<p>Leader In Me is an evidence-based, comprehensive model that builds leadership and life skills in students. It creates a high-trust school culture and lays the foundation for sustained academic achievement</p>

<p>The Leader In Me program establishes a whole-child mindset with a belief that every child has a genius and every student has the potential to become a leader. The program will be implemented by the teacher/classroom. The Leader In Me aligns with character education, and whole child development, and supports staff and students with understanding and managing their emotions, setting and achieving positive goals, how to feel and show empathy for others, and establishing and maintaining positive relationships.</p>

<p>Improved healthy identities, ability to create meaningful relationships, and engage productively. Pre and post-teacher surveys to measure skills development. Reduction of problem behaviors.</p>	

Evidence-Based Program	Crisis Prevention Intervention Training (CPI) (K-12)
Tier(s) of Implementation	Tier 1
Describe the key EBP components that will be implemented.	
CPI training is part of comprehensive crisis prevention and intervention plan and teaches participants how to defuse challenging and disruptive behavior before an incident escalates into a crisis.

The Nonviolent Crisis Intervention program can be taught in one of two ways- in its entirety in a classroom setting or as a hybrid option. In the hybrid option, participants receive much of the content in a web-based format, followed by a classroom session designed to help apply that content to workplace situations.

No increase in physical restraint. Decrease the total number of involuntary examinations. Other supported outcomes: Certified Instructors repeatedly report the value of the program’s approach of viewing the crisis moment more holistically- as a component of an individual’s behavior. The user-friendly principles of the Nonviolent Crisis Intervention training program give staff easy-to-understand behavior de-escalation tools to incorporate into their daily interactions with students.

<p>Positive Behavioral Interventions and Supports (PBIS) is an evidence-based, tiered framework for supporting students' behavioral, academic, social, emotional, and mental health. When implemented with fidelity, PBIS improves social & emotional competence, academic success, and school climate. It also improves teacher health and well-being. It is a way to create positive, predictable, equitable, and safe learning environments where everyone thrives.</p>

<p>PBIS establishes efficient and functional ways to engage and empower parents to become more aware, informed, and involved in the education and well-being of their children within the school environment. The district and professional staff will assist the school staff in carrying out this function. The district will place on its website contact information for available community resources. The school social worker will respond to the needs identified by the families or school, which may involve, but is not limited to the need for food, housing, shelter, clothing, and medical care. Mental health professionals will disseminate information to parents on mental health awareness and at-risk behaviors and available community mental health resources.</p>

<p>PBIS is a framework for creating safe, positive, equitable schools, where every student can feel valued, connected to the school community, and supported by caring adults. By implementing evidence-based practices within a PBIS framework, schools support their student's academic, social, emotional, and behavioral success, engage with families to create locally-meaningful and culturally-relevant outcomes and use data to make informed decisions that improve the way things work for everyone.</p>

Tier(s) of Implementation	Tier 1
Describe the key EBP components that will be implemented.	
<p>EverFi focuses on the following supports: Supporting students in identifying threats to mental health early and taking measures to increase factors that protect mental health. Introducing students to the experiences of others in order to develop awareness and empathy, reduce stigma, and provide facts on the prevalence and symptoms of mental health conditions. Fostering a mental health mindset to help students develop feelings of self-efficacy and skills that promote and model advocacy for self and others.</p>	
<p>Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.</p>	
<p>School-based mental health team and classroom teachers will provide support in implementing EverFi at all applicable grade levels. Lesson modules include an introduction to mental health, understanding mental health disorders, healthy coping skills, and health and wellness. Lessons are integrated into the curriculum and activities are provided. A pre and post-test will be used to determine student understanding.</p>

Mental Health interventions using therapeutic modalities including Cognitive Behavior Therapy, Solution Focused Brief Therapy and Motivational Interviewing.	
Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.	
Mental Health professionals will further screen and identify referred students who need individual or small-group counseling or mental health support. The supports provided include relaxation coping, resiliency, and self-esteem building. Strengths-based interventions that are brief and goal-oriented will be utilized.

<p>Cloud9World is a unique and innovative learning program that integrates literacy as the vehicle for teaching character strengths. Our program utilizes the acquisition and strengthening of emotional management strategies and character to develop greater personal mental health and the capacity to make wise choices for a well-rounded life and a thriving society.</p>	
<p>Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.</p>	
<p>The Cloud9World programs utilize a social constructivist approach that enables students to experience and embrace positive character strengths. This approach is easily recognizable in the lesson plans and curriculum components. Rather than being told what to experience, the activities encourage children to experience character strength, express themselves as they embrace the character strength, and then apply the strength to other areas of their lives. All resources and materials are designed for flexible use throughout the school day and are completely open and accessible by teachers, parents, and students at their points of need as well as scheduled classroom implementation.</p>

Direct employment policy, roles and responsibilities

Explain how direct employment of school-based mental health services providers (school psychologists, school social workers, school counselors and other licensed mental health professionals) will reduce staff-to-student ratios.

LWCS for the 22-23 school year, implemented a plan to have a minimum of 1 full-time social worker on each campus. For the 23-24 school year, we will continue to provide a minimum of 1 mental health professional on each school campus for our students. Continuing to staff a mental health professional at each school will allow for the delivery of a full range of services and effective school-community partnerships. This individual will provide regular support to their assigned school and ensure the following:

- Students referred for a mental health screening are assessed within 15 days of referral;
- School-based mental health services are initiated within 15 days of identification and assessment;
- Collaborate with the discipline team to ensure effective, positive school discipline that: (a) functions in concert with efforts to address school safety and climate; (b) is not simply punitive (e.g., zero tolerance); (c) is clear, consistent, and equitable; and (d) reinforces positive behaviors.
- Integrating learning supports (e.g., behavioral, mental health, and social services), and instruction within a comprehensive, cohesive approach that facilitates multidisciplinary collaboration.
- Implementing multi-tiered systems of support (MTSS) that encompass prevention, wellness promotion, and interventions that increase with intensity based on student need, and that promote close school-community collaboration.

Describe your district's established policies and procedures to increase the amount of time student services personnel spend providing direct mental health services (e.g., review and revision of staffing allocations based on school or student mental health assistance needs).

School-based mental health staff review data and determine student mental health needs. Health Services district staff review individual school data and adjust health services staffing ratios based on student mental health needs. District and school-based MTSS team meetings will be held quarterly to map out necessary resources to address T1, 2, and 3 needs and determine where mental health staff can be most effectively utilized.

Describe the role of school based mental health providers and community-based partners in the implementation of your evidence-based mental health program.

LWCS collaborates with a range of school-based and community-based stakeholders invested in integrated approaches to reduce mental health care barriers to students. Our school-based mental health providers are key to the success of our EBPs throughout our district and work closely with contracted mental health providers.
