CENTER RULES

The child shall not do anything that would inflict harm physically or verbally on himself, fellow students or any other person. The child shall not misuse or intentionally damage day care property or an individual's property. The child shall participate in group learning activities displaying age appropriate social behavior. E.g. using quiet voices inside, remaining seated during work circle time as the workers instruct, walking, rather than running inside the building. Children shall not be verbally or physically defiant to the staff.

DISCIPLINARY ACTION

It is our desire to provide your child with the best possible atmosphere & program. In order for us to do this, we need to maintain discipline and order. Brite Beginnings discipline will provide for positive guidance, redirection and the setting of clear-cut limits. It is designed to help the child develop self-control, self-esteem, sensitivity to the needs of others and respect for the rights of others.

No child shall be subject to physical punishment, corporal punishment, verbal abuse or threats. The following actions are prohibited: yelling, slapping, spanking, yanking, shaking, pinching, requiring a child to exercise, placing a child into uncomfortable positions, exposing a child to extreme temperatures and other measures producing physical pain, putting anything in a child's mouth, using abusive or profane language including telling a child to shut up. Cruel, severe, unu8sual or unnecessary punishment shall not be inflicted upon children. Derogatory remarks shall not be made in the presence of children about family members of children in care or about the children themselves. No child shall be deprived of meals or snacks or any part thereof for behavior management reasons. Children shall not be restrained by devices, such as high chairs or feeding tables. No child or group of children shall be removed from the group for discipline reasons and placed in a room by him/her self. They will be placed in "time out" in sight of a staff member. Brite Beginnings disciplinary procedures are as follows:

One & Two Year Olds

* For instances of misbehavior, redirection techniques will be used.

Three, Four & Five Year Olds

* For each episode of misbehavior, redirection techniques will be used first. If misbehavior continues then "time out" will be used for three to five minutes maximum per episode.

Six Years and Up

* Time out shall not exceed 15 minutes

Welcome to Brite Beginnings. It is with great pleasure that we welcome you and your child to our learning facility. Your child's experiences and happiness are our primary concerns. We voluntarily participate in the USDA's food program and hold a Two Star Rating with the La. Quality Start Program.

The curriculum and daily schedules are designed to encourage children to learn through guided play. The learning environment for young children should be one in which they are free to explore and gain positive experiences that allow them to enjoy learning. All children learn through active exploration of their environment.
