

WEBSTER COUNTY BOARD OF EDUCATION  
REGULAR SESSION  
NOVEMBER 11, 2025 @ 6:00 P.M.

The Webster County Board of Education held its regular meeting on November 11, 2025 at 6:00 p.m. Linda Rogers, Donald Brown, Jimmie Johnson, and James McCullough, Interim Superintendent, were present. Landon Matthews was absent.

Linda Rogers called the special called session to order at 6:00 P.M.

A moment of silence was observed followed by the Pledge of Allegiance.

Visitors were recognized by Linda Rogers.

Public comments were given by Janie Downer.

The Board approved the tentative agenda for November 11, 2025. A motion was made by Jimmie Johnson and seconded by Donald Brown. The motion carried unanimously.

The Board approved the September 2025 Financial Report. A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board reviewed the reconciliation report.

The Board approved the October 7, 2025 (6:00 pm) regular session minutes. A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved the October 10, 2025 (6:00 pm) special called meeting minutes. A motion was made by Jimmie Johnson and seconded by Donald Brown. The motion carried unanimously.

The Board approved to enter three floats (Pre-K, 7<sup>th</sup> Grade AG, and Chorus) into the Preston Christmas Parade on December 25<sup>th</sup>. (\$25 per float) A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved Christopher Whitaker as a volunteer for our FFA Club. A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved repairs to bus #20-20, damaged by hitting a deer, to be completed by Peach State Trucking in the amount of \$16,984.45. (Transportation/Insurance). A motion was made by Donald Brown and seconded by Jimmie Johnson. The motion carried unanimously.

The Board approved Title II and Title IV budgets. A motion was made by Jimmie Johnson and seconded by Donald Brown. The motion carried unanimously.

The Board approved a one time custodian supplement provided by state funds for two custodians. A motion was made by Jimmie Johnson and seconded by Donald Brown. The motion carried unanimously.

The Board approved to purchase Documenting Software for Chief Thomas from Verticals Interop Public Safety in the amount of \$6,800.00. A motion was made by Jimmie Johnson and seconded by Donald Brown. The motion carried unanimously.

The Board approved the Personnel Agenda:

- a. The resignation of Janet Walls effective November 14, 2025.
- b. To pay Aaron Schroeder a supplement of \$50 per basketball game to prepare concession food and work late to clean the gym after each game.
