Frequently Asked Questions

What do I do if I . . .

1. HAVE BEEN ABSENT?

If you have been absent, you must bring a written excuse from your parent stating the reason for your absence. It is the student's responsibility to turn in documentation before the beginning of the school day. This written excuse is to be turned in to the attendance office, and the original notes will be kept on file. These will be needed in the event of an absence related discrepancy. This written note must be brought to school within 3 days after the absence and must contain the following information:

Date of Note
Date of Absence
Reason for Absence
Parent Signature
Phone Number of Parent

The State Board of Education policy allows only the following circumstances as excused absences:

- 1. Personal illness
- 2. Death or serious illness in the immediately family
- 3. Recognized religious holidays
- 4. Absences mandated by a governmental agency
- 5. Conditions which render school attendance impossible or hazardous to the student's safety and health
- 6. Students who serve as a page in the General Assembly

All other reasons will be classified unexcused. When 5 unexcused absences have accrued, the student is considered truant.

Veterans High School shall enforce the Georgia Compulsory Attendance Law, Mandatory Attendance, which requires that all students between the ages of 6 and 15 attend school. All students missing more than 5 unexcused days in Georgia are declared as truant by law.

Veterans High School students are affected by and fall under the provisions of our attendance protocol which is stated as follows:

Level I: Three (3) unexcused absences. A letter will be mailed home by the Attendance Office.

Level II: Five (5) unexcused absences. School staff will notify parents of the truancy and request a conference with the parents to sign an Attendance Contract.

Level III: Eight (8) unexcused absences. School staff notifies Social Services Department; Social Services provides data to the court for judicial proceedings to begin, or warning for students 15 or younger.

Military Family Deployment - Absences for Special Consideration

Veterans High School is supportive of our military families, especially during the difficult time of deployment. In an effort to ease the burden of our students who have parents deploying, Houston County Schools will allow up to a total of 10 days of administratively excused (AE) absences each academic year to allow families time during the deployment cycle. Absences may be planned to best fit your individual family needs. Excused absences will be allowed for the following situations:

- Pre-deployment, the day before deployment one day;
- Day of departure one day;
- Reunion, post-deployment one day;
- R&R break-up to three days; or
- Travel to visit an injured parent up to five days.

Forms may be picked up in the Attendance Office.

2. NEED TO LEAVE SCHOOL EARLY?

A written parent request must be made before permission will be given for a student to leave campus early for any reason. The written request must be taken to the attendance window prior to the beginning of the school day. All notes requesting an early dismissal must contain the full name of the student and a telephone number where a parent may be reached for confirmation. At the time of the dismissal, the student must sign out in the attendance office.

Appointments should be arranged for after school hours when possible. Remember that each teacher keeps individual attendance. Students must provide verification from their doctor or dentist in order for school time missed to be counted as excused. It is the student's responsibility to prove all absences were documented excused. Notes written after the third day grace period will not be accepted.

Students who arrive or leave school outside of the regular school times must enter/leave school through the attendance office and the main entrance.

3. AM TARDY TO SCHOOL/CLASS?

Tardy to school will be defined as arriving to school at 8:00 AM or later. If a student is late to school, he or she will report to the attendance office to check in and receive an admit slip to class.

- Attendance for 1st 7th periods will be taken by each teacher.
- Tardies to 2nd 7th periods will be recorded by each teacher. No students will be sent to the office to have tardies recorded during the school day.
- All tardies will be cumulative each semester.
- Discipline will be as follows for accumulated tardies:

3rd tardy: warning conference/tardy notice

6th tardy: alternative discipline

9th tardy: automatic .5 day of ISS

12th tardy: automatic 2 days of ISS

15th tardy: automatic 5 days of ISS/behavior contract

Subsequent tardy discipline is at the discretion of the administration, and discipline will be assigned progressively.

4. NEED TO USE THE PHONE?

Office telephones are to be used only with the permission of office personnel. Students using the office phone must sign the phone log. Students will not be allowed to use school phones unless they are conducting school business. Sick students should be sent to the Med Tech/Clinic with a pass. In case of emergency, a student must have a pass from a teacher to use the phone in the attendance office. Failure to follow this standard procedure may result in disciplinary action.

5. ARRIVE AT SCHOOL EARLY/NEED TO LEAVE SCHOOL EARLY?

The school building will not be officially open to students until 7:15 AM. Any student who arrives prior to 7:40 AM should report to the cafeteria, and students will remain in the cafeteria until 7:40 AM.

Students need to remember that once they arrive on the campus or board a school bus, they are considered to be officially at school.

Students should arrive and enter the building as follows:

Bus riders: Students should exit the bus upon direction and enter through the bus ramp entrance only.

Car riders: Students should be dropped off at the front of the building and enter through the main office entrance only.

Student drivers: Students should park in their designated spots and enter through the gym parking entrance only. Student drivers should exit their vehicle and enter the building upon arrival.

Any student who needs early dismissal should do so through the attendance office. Documentation for early dismissal should be turned in at the attendance office prior to the beginning of school, and the student should sign out through the attendance office at the appropriate time. If a student needs to leave early in an unplanned fashion, the parent can call the attendance office to authorize early dismissal. All entrances/exits outside of the school day hours must go through the main entrance.

Any student who leaves campus for any reason without following the appropriate check-out procedures will be subject to disciplinary action. This rule applies even if you leave before 1st period starts.

6. REMAIN AFTER SCHOOL?

School ends daily at 3:00 PM. Students are strongly encouraged to participate in extracurricular activities; however, students who are participating in activities should be in the area of activity under staff member supervision. Students may not loiter in the building or in other unsupervised areas, and students not in supervised school activities are expected to leave campus by 3:15 PM.

7. HAVE LOST SOMETHING?

Students who lose, misplace, or feel they have had something stolen, need to report the incident to school personnel immediately; a member of the clerical staff in the front office can assist students with incident reports. A lost and found area is also located in the front office. All misplaced textbooks that are turned in or found by faculty members will be returned to the appropriate department chair. Students are responsible for all items issued to them by the school and all personal items; the school does not assume responsibility for lost or stolen items.

8. HAVE AN ELECTRONIC DEVICE?

In compliance with local policy JCDAF, students are permitted to possess cell phones and other electronic devices while on school property and during school functions.

Recreational use of these devices is not permitted during the school day from student arrival on campus to school dismissal (3:00 PM). Listening devices, such as ear buds, headphones, and blue tooth devices, are also not permitted. Students who violate this policy shall be subject to appropriate disciplinary action. Electronic needs for instructional purposes will be met through school-issued chrome books, as assigned to all students.

Veterans High School will not be responsible for lost or stolen personal communication or personal electronic devices.

9. HAVE FORGOTTEN SCHOOL RELATED MARTERIALS/PROJECTS IN MY VEHICLE?

Students are not permitted in the parking lots during the school day for any reason. Students must have all needed materials before entering the building for the school day. Administrators and the school resource officer check the parking lots throughout the day for school safety and security.

10. NEED TO SEE A COUNSELOR?

The counselor is one of the most important individuals a student can get to know in a high school. Counselors are directly responsible for student schedules, post-secondary information, personal counseling, and student records, to name a few. An appointment is needed if you need to see a counselor. This appointment can be made with the counseling office secretary. Emergency situations will be addressed at any time. Students who have a personal emergency and need to see a counselor during the class time must get a note from their current teacher. Because counselors are involved in testing, classroom guidance, registration, and other conferences/duties, emergency situations are handled on an on-call basis. Students who have conflicts with other students should see the counselors. Many times conflicts can be resolved with minimal disruption if school personnel are made aware of the problem early. 11. NEED TO SCHEDULE A CONFERENCE?

Veterans High School wants all procedures, expectations, and decisions to be fair and consistent. In some situations, parents or students may need to conference to discuss student needs or consequences. For classroom needs, the teacher is the first point of contact. Please contact the teacher via email or phone call. If necessary, contact the counseling office to set up a teacher conference. If a conference is needed with a counselor for academic planning, dual enrollment needs, or other student supports, contact the counseling office. If a conference is needed for special education services or supports, please contact the student's case manager.

12. NEED FIRST AID, MEDICAL ATTENTION, OR MEDICATION?

If a student becomes ill during the school day, he/she should report to the med tech's office/clinic and a call will be made to the parent. Parents requesting permission for their student to check out of school will go through the office staff. These dismissals will be excused or unexcused, and the same regulations will apply to graded and make-up work as far as daily absences. Any student who is injured at school should notify school personnel immediately. Students who are injured are required to fill out an accident report with the med tech.

Students who are under a doctor's care and require medication during the school day need to report this condition, with the appropriate medical documentation, to the med tech in the clinic. All prescription medication must be housed in the clinic and can only be administered by approved personnel. Students should not have any type of medication on their person. Students should never under any circumstances share or take medication from another student. Any student caught with unregistered medication, including over-the-counter medications, will face disciplinary action.

13. NEED TO KNOW ABOUT CLASS PROGRESS?

It is important to stay aware of academic progress and needs throughout the school year. Report cards are issued and credit is granted every 18 weeks at the end of each semester. Progress reports are sent home every six weeks. The dates for progress reports are scheduled:

Current grades and attendance may be monitored through Infinite Campus. Parents must register online to obtain a username and password; parents must have the student number, social security number, and date of birth to register online. Students also have Infinite Campus access accounts. For more information or to register go to http://www.hcbe.net/parents.htm. If you need help registering, please contact the ATS clerk in the counseling office.

Georgia Milestone Assessments, state standardized exams, are required in the following high school courses: American Literature, Biology, Algebra, and US History.

GUIDELINES AND PROCEDURES

Academic Integrity

The academic integrity of courses at VHS is of the utmost importance; as such, cheating or academic dishonesty will not be tolerated. If a student cheats or plagiarizes on any assessment, the result is a zero as a placeholder until the student has had the opportunity to demonstrate learning on an alternate assignment; the teacher must make parent contact.

If the cheating or plagiarism occurs on a major assessment, the student should be referred to an administrator for review. Cheating or plagiarism on a major assessment will also result in alternative discipline or in-school suspension. The ISS assignment will be progressively graduated if it is a repeated offense.

Students who take Advanced Placement courses have the opportunity to take the College Board/AP exam in May to earn subsequent college credits. Students interested in taking AP courses should contact Mrs. Brock or a counselor for details.

Advisement Program

All students are part of the advisement program. Parents should check their student's transcripts, monitor progress through Infinite Campus, and meet with counselors periodically to ensure student success.

Evening advisement will be held to provide parents with the opportunity for input regarding course selection and academic progress during the month of March. Evening advisement information including the designated date/time will be mailed to parents.

Attendance

In the System Guidelines and Policies portion of the handbook, state and county rules regarding absences from class are defined.

In addition to these rules, VHS students should note the following:

- It is the responsibility of the student to obtain any work missed and arrange for any test makeups as a result of absences.
- Skipping constitutes an unexcused absence and will result in disciplinary action.
- Students who are failing 2 or more classes may not be allowed to attend a scheduled NI at the discretion of the principal. NIs are absences for activities such as non-instructional field trips or extracurricular activities.
- Work missed during an NI will be expected to be made up the next school day if the work
 missed was announced prior to the absence. Work previously announced prior to a regular
 single absence should also be made up the following day. In the case of extended absences, the
 student must make up missed work within 5 school days. This should be arranged before or
 after school and at the convenience of the teacher.
- Students must follow attendance procedures outlined in this handbook. Students who are
 absent have 3 days in which to present a note stating the reason for their absences.
 Responsibility for proving that an absence is excused falls directly on the student. Students
 who are out for 10 or more consecutive days for a medically documented illness should apply
 for hospital homebound services.
- Exemption status is contingent on students having 5 or fewer absences in the given semester, not including NIs. There are no exceptions granted for exceeding the five-absence requirement.

Beginning of the Day

Students may be dropped off no earlier than 7:15 AM, and students should not be on campus prior to that time. The main entrance and the student parking lot gym entrance are open at 7:15 AM.

Bullying

In accordance with Georgia law, bullying is defined as:

- 1. Any willful attempt or threat to inflict injury on another person, when accompanied by an apparent present ability to do so; or
- 2. Any intentional display of force such as would give the victim reason to fear or expect immediate bodily harm; or
- 3. Any intentional written, verbal, or physical act which a reasonable person would perceive as being intended to threaten, harass, or intimidate, that
 - a. Cause another person substantial physical harm within the meaning of Code Section 16-5-23.1 or visible bodily harm as such term is defined in Code Section 16-5-23.1:
 - b. Has the effect of substantially interfering with a student's education;
 - c. Is so severe, persistent, or pervasive that it creates an intimidating or threatening educational environment; or
 - d. Has the effect of substantially disrupting the orderly operation of the school.

Any bullying incident should be reported to an administrator immediately.

Cafeteria

Breakfast and lunch will be served at school daily; breakfast costs \$2.00, and lunch costs \$3.00 for students. Menus can be found at www.hcbe.net/schoolnutrition.

Free and reduced meals will still be available to those who qualify, which can be found at https://www.hcbe.net/snpcommunityeligibility. Reduced price is \$.30 for breakfast and \$.40 for lunch. More information on school meals including pricing, free and reduced meal applications, and Q&A's can be found by visiting https://www.hcbe.net/schoolnutrition.

For the school year 2024-2025, Houston County School District is requesting all families to complete a Free and Reduced Meal Application. Our system receives a variety of funding, which is linked to the completion of this form. The fastest way to complete the form is to visit https://www.nlappscloud.com.

Snacks are available for purchase at the register. For speed of service and convenience, we encourage families to put money on their students' accounts at www.myschoolbucks.com. Checks should be made payable to Houston County School Nutrition and the student's ID number should be written on the check or clearly labeled on an envelope containing cash; payment drop boxes are available in the attendance office and the main cafeteria for in-house payments.

Students are expected to respect other students and the cafeteria space. Trash should be placed in appropriate receptacles. Students should go to the cafeteria in an orderly manner. Cutting in the lunch lines will not be permitted. All papers, food, and other trash should be removed from the floor, table, and grounds wherever lunch is consumed. Good manners and cleanliness are expected at all times.

College Visitations

Seniors will be allowed one excused absence, not a school NI, for the purpose of visiting universities, colleges, technical or vocational schools in a school year.

Confiscated Items

Confiscated items (i.e., hats, electronic devices) may be picked up in the front office after 3:00 PM.

CTAE Pathways

Students who graduate from high school after successfully completing a CTAE "Career Pathway" are equipped for immediate employment, post-secondary education and life-long learning. In essence, students in CTAE are "college, career and workforce ready" - prepared to compete in the global marketplace.

The decisions made regarding which CTAE courses to take and career interests to pursue will affect the rest of a student's life. The CTAE Pathway selected should align with personal interests and future goals. Whether interested in agriculture, food and nutrition, marketing, graphics or business, there are class offerings that will provide the foundation and knowledge for growth in the skills and talents needed to make the most of an individual's interests.

Pathways consist of 3 courses in a related field that are taken sequentially. Veterans High School offers the following CTAE pathways on campus:

- AFJROTC
- Agriculture (Ag Mechanics, Food Animal Systems, Forestry/Wildlife)
- Business and Computer Science (Business & Technology, Entrepreneurship, and Financial Services)
- Early Childhood Education

- Family & Consumer Science (Food & Nutrition)
- Graphics (Graphic Communication)
- Marketing, Sales & Service (Sports & Entertainment Marketing)

Additional career pathways are offered through the Houston County Career Academy (HCCA). For information on those pathways, please see a counselor.

Every educational journey is different, and students should take full advantage of these pathway offerings to explore and develop passions and unique skills.

Deliveries

Students may not receive personal deliveries of any kind, such as flowers, balloons, candy, or food, during the school day. This includes deliveries from commercial vendors, delivery services, friends, or parents.

Discipline

School is a place designed to promote positive learning experiences. This process becomes limited when students choose to be disruptive or non-compliant. Research shows that students learn best and teachers provide the best instruction in a safe and orderly environment. Students who choose to violate school rules and policies will receive consequences accordingly. Parents are strongly encouraged to contact administrators, counselors, and/or teachers should discipline problems arise with their student. Offenses involving drugs, alcohol, violence, sexual misconduct, or theft are considered extremely serious and may result in immediate recommendation to tribunal and/or involvement of law enforcement officials.

Veterans High School uses a progressive discipline system; each incident has a progression of discipline based on the severity of the infraction. The consequence severity and type will increase with each reported incident. Each student will be disciplined according to the particular incident and his/her cumulative discipline history. Any student involved in physical altercations/fighting will be issued a ticket and/or be arrested by the Houston County Sheriff's Department. NOTE: It is conceivable that two students could be involved in the same incident and receive different punishments if their discipline histories are different.

In the System Guidelines and Policies portion of the handbook, state and county rules regarding discipline are defined. Possible consequences include conferencing, teacher detention, administrative detention, dismissal of bus transportation, dismissal of parking privileges, dismissal of technology use, in-school suspension, behavior-discipline contract, restitution, out of school suspension, alternative discipline, notification of law enforcement, and/or tribunal hearing.

Dress Code

Expectations for student dress are outlined in the Houston County Board of Education Policy JCDB, and local rules are defined in the System Guidelines and Policies portion of the handbook. Students who are found to be in violation of the dress code are subject to disciplinary action. Highlights of the student dress code include these provisions:

- 1. Obscene pictures, symbols, or depictions of weapons, illegal drugs, tobacco products or alcoholic beverages, inflammatory, suggestive, racial, or other inappropriate writing, advertisement, or artwork shall not appear on clothing.
- 2. Extremes of dress shall not be permitted. These include lack of cleanliness, bare feet, bare midriffs, tank tops, see-through clothing, pajamas, etc.
- 3. When leggings are worn, a dress, skirt, or shirt must be worn over the leggings to the natural mid-thigh length.

- 4. Shorts, skirts, and dresses should be mid-thigh or longer.
- 5. Clothing which is cut, slashed, or has holes and exposes skin above the knee is prohibited.
- 6. Sagging pants are not allowed, and pants must be worn at the waist.
- 7. Head coverings are not allowed in the building during the instructional day.

Disciplinary actions may include:

- Counseling the student,
- Warning the student,
- Calling parents to bring a change of clothes,
- Saturday School,
- Alternative Discipline,
- Placing the student in in-school suspension for the remainder of the day,
- Suspending the student short term, or
- Recommending long-term suspension (for flagrant or repeated violations).

All clothing is to be worn appropriately and in the manner for which it was designed. The school reserves the right to establish rules during the school year regarding new fashions in dress. Principal discretion applies to all of the above.

Dual Enrollment

Earning college credit while in high school is an option for students in the Houston County School System through Dual Enrollment. Eligible high school students may enroll full-time or part-time in college-level approved courses through Dual Enrollment. Dual Enrollment provides opportunities for Georgia high school students to take college-level approved courses, which earn both high school and college credit simultaneously. Houston County Board of Education will set a registration deadline that is different from the postsecondary institutions. Deadlines will not be waivered due to college entrance exams score reports.

Students who participate in Dual Enrollment program are expected to do the following:

- Enter and exit the building through the main entrance
- Use resources such as the attendance office, the school web site, and the counselor's office to stay informed of school events (i.e. progress reports, prom, graduation, scholarships, senior activities)
- Keep up with schedule changes due to school activities
- Maintain school dress and school rules any time on campus

Limited Dual Enrollment courses through Central Georgia Technical College are offered to qualifying juniors and seniors on campus; more information is available through the counseling office.

Electronic Devices

Students are permitted to possess cell phones and other electronic devices while on school property and during school functions but are not visible or in use from student arrival to school dismissal on instructional days.

Cell phones should not be charged, and ear buds/Bluetooth should not be used while at school. Students who violate this policy shall be subject to appropriate disciplinary action.

1st offense: Warning, phone agreement, & confiscation of device (pick up after 3:00 PM)

2nd offense: .5 day of ISS or alternative discipline & confiscation of device (pick up after 3:00 PM)

3rd offense: 1 day of ISS

Refusal to surrender device to a staff member is failure to follow direct request and will result in 3 days ISS. VHS is not responsible for lost or stolen electronic devices.

End of School Day

The regular school day ends at 3:00 PM. All students should be off campus no later than 3:15 PM unless they are under the direct supervision of a staff member.

Extracurricular/Co-Curricular Activities

Students learn teamwork, discipline, responsibility, and many other social skills through participation in extracurricular activities. Participation in extracurricular activities is considered an integral part of high school life that enhances the development of the total student. To participate in competitive extracurricular activities, students must meet all eligibility requirements and other policies governing participation as set forth by Georgia High School Association and the local Board of Education who are responsible for establishing eligibility requirements. Below are the general guidelines for eligibility. All eligibility issues should be discussed with the athletic director.

Participation in any extracurricular activity or sport is a privilege, not a right, and is subject to school/coach/sponsor requirements, expectations, and procedures.

The following information is in effect as of July 1, 2003:

- All academic requirements are based on a minimum passing grade of 70.
- GHSA refers to the Georgia High School Association activities that are governed by that body.
- State Board of Education No Pass/No Play policy pertains only to competitive interscholastic activities.
- Approved high school and middle school summer school is an extension of the spring semester.
- All students must meet the following requirements to be eligible:
 - Age To be eligible to participate in interscholastic activities a student must not have reached his/her 19th birthday prior to May 1st preceding his/her year of participation.
 - Semesters -students are only eligible to participate for 8 consecutive semesters from the time they enroll in their first 9th grade course. (Alg. I in the 8th grade does not count in the semester rule).
 - Home school enrollment Students must participate in activities at the school where they
 first entered the 9th grade. Students who enroll in another high school during their 8
 semesters are subject to migratory rule requirements and a form B must be completed.
 - Students must pass 5 out of 7 classes and meet on-track requirements.

All students who are entering the 9th grade for the first time are eligible for the first semester provided they meet the age requirement. At the end of the 1st semester and every semester thereafter, students must pass 5 out of 7 classes, meet on track requirements, and satisfy the age requirements. In addition to the above GHSA and state requirements, all students must have a current physical form on file, a parent permission form, and an insurance waiver form to be eligible to participate.

In order to participate in extracurricular activities, a student must be counted present on the day of participation. Ex: A student may not stay home for the day then participate in a contest that afternoon or evening.

Students should remember that the same discipline expectations, rules, and regulations are in effect at any school-sponsored event in any location as would be expected on campus during the school day.

Guidance/Counseling Office

Services available through the guidance/counseling office include: personal counseling to students, individual and group activities for academic, emotional and career development, information about course offerings and programs, college and career information and counseling, scholarship and financial assistance for post-secondary opportunities. The Counseling office also coordinates intervention/prevention services, maintains all student records, provides ASSET, PSAT, SAT, and ACT information,

and coordinates school-wide testing services. Parent conferences should be scheduled through the counseling office.

Lockers

General lockers in the main building are issued based on student request. Students may contact the front office for a locker assignment. Contents of the locker are the repsonsiblity of the assigned student, and lockers are subject to search at any time.

Gym lockers are available in physical education classes, and students are encouraged to use these lockers during gym. Students should see their teacher for gym locker use. Students are responsible for the contents of their lockers at all times, and the school is not responsible for stolen items.

Media Center

The Media Center opens daily at 7:40 AM and closes at 3:30 PM. Students going to the Media Center during class time should have a pass from their current teacher. Books may be kept for a two-week loan period. Students needing more than five books at a time should consult with a Media Specialist. Students are reminded that Internet/computer access is provided in the Media Center, but classroom assignments may supersede individual student use. All students who use the Internet must have an Internet agreement on file. Students who misuse, abuse, or in any way manipulate the internet for purposes other than research will be subject to severe disciplinary action by the school administration.

Obligations

Students are directly responsible for all debts incurred during the school year. Students should be aware that items issued directly to them are their responsibility until the item is officially returned; such items include chrome books, textbooks, calculators, uniforms, instruments, and like school equipment. All student obligations shall be cleared before the end of the semester they are incurred. Students will not be issued replacement textbooks or equipment until the obligation has been cleared. Students will not be allowed to participate in dances (homecoming/prom), the graduation ceremony, or field day until all fines are cleared; additionally, students will not be allowed to exempt any final exam until all obligations are cleared.

Parking

The operation and parking of a vehicle on campus is a privilege granted by the school to students who have a valid driver's license. Students should remember that they are directly responsible for every item in their vehicles, and vehicles are subject to random search at any time.

All students are expected to observe traffic regulations. The school reserves the right to suspend and/or revoke campus parking privileges of any student who violates parking rules and regulations or is not in good standing in the school. Students whose permits are revoked will not be reimbursed any portion of the parking fee.

All vehicles must be registered if they are parked on campus during the school day. The registrant of a motor vehicle is held responsible for the proper use, all contents, parking, and operation of his/her vehicle. All vehicles must have a visible parking permit while on school property. No parking permit is to be transferred, sold, loaned, or given to another student.

Parking permits can be purchased from the school receptionist in the front office before or after school. Parking rules and required documentation information are available on the school website or from the school receptionist.

Respect for Staff and Equipment

VHS students are fortunate to have the privilege of attending school in a modern, well-maintained facility. Students should take pride in their school and make every possible effort to help maintain its appearance and cleanliness. Each student is expected to assume responsibility for the care of all school property. Students who damage property accidentally are responsible for paying for the damage. Students who willfully deface or damage school property in any way shall pay in full for all damages and/or repair and will receive appropriate disciplinary action.

It is the student's responsibility to comply with classroom and school rules. Students are required at all times to obey school expectations and reasonable requests from faculty members. This includes identifying themselves to faculty members when asked to do so. Failure to respond appropriately or refusal to follow the direct request of a faculty member will result in disciplinary action.

Schedule Changes/Dropping Courses

After registration, schedules will only be changed for the following reasons:

- A student is in a class for which he/she has already received credit.
- A student needs a credit for graduation.
- A student is enrolled in a class that he/she has previously failed under the assigned instructor.

All schedule changes must be completed during the first ten days of the new semester. Neither students nor parents are allowed to request teachers or change schedules from selections made at registration. Students and parents are strongly encouraged to check schedules at the beginning of each semester to make sure the student is in the appropriate level and proper course sequence. Any scheduling concerns should be addressed with the student's counselor.

School Council

VHS hosted its first School Council during the 2011-2012 school year. This council serves as an advisory body, consisting of two parents, two teachers, two business partners, and the school principal. The council can provide advice and recommendations to the school principal and, where appropriate, the local board of education on matters relevant to the school, district, and/or community. The council meets at least four times per year, and those dates are publicized on the school website and through local media.

Section 504

Section 504 of the Rehabilitation Action of 1973 prohibits discrimination and assures that disabled students have educational opportunities and benefits equal to those provided to non-disabled students. Any inquiries concerning Section 504 may be referred to our school's Section 504 Coordinator, Daphne McMahon.

Semester Final Exams

Final exams will be given on the last three days of each semester. Students and parents are asked not to schedule vacations and out-of-town trips on exam days. EXAMS WILL NOT BE ADMINISTERED EARLY EITHER SEMESTER.

Students may exempt their exams if they meet the following criteria:

- 1. have a B average (80 or above) in the course,
- 2. have no more than 5 excused or unexcused absences over the course of the semester,
- 3. must not have received Hospital Homebound Services,

- 4. must not have been assigned ISS/OSS during the semester, and
- 5. must have cleared all financial/material/school property obligations to the school.

Exceptions to the district-established required criteria for exemptions are not made.

Standardized Testing

PSAT: This examination is an excellent opportunity for students to understand the requirements of the SAT, which is a critical reasoning exam used as a criteria in college admissions. Tenth grade students who participate in the October administration of the PSAT at their home high school receive a detailed Score Report Plus in December. The Score Report Plus provides students with a comprehensive skills' analysis of their performance and gives them a code which provides access to a website with additional test information and an interactive career information program called My Roads.

Students may take the PSAT as freshman or junior for a fee. Junior students who take the PSAT are eligible to be considered for National Merit Scholarship. Confer with your student's counselor in August about ordering the PSAT for your junior.

The counseling department facilitates registration and admission of the PSAT at the school level; this year's administration is October 23, 2024.

SAT: The SAT reasoning test is a measure of the critical thinking skills needed for academic success in college. The SAT assesses how well a student analyzes and solves problems. All colleges and universities in Georgia accept scores from the SAT for admission purposes. The College Board determines the national testing dates and testing sites for the SAT exam.

Students are responsible for registration and payment for SAT testing online. Students may register at: www.collegeboard.com/student/testing/sat. The College Board offers fee waivers for students meeting certain financial criteria.

ACT: The ACT examination assesses high school students' general educational development and their ability to complete college level work. All colleges and universities in Georgia accept scores from the ACT for admission purposes. **ACT** determines the national testing dates and testing sites for the ACT exam.

Students are responsible for registration and payment for ACT testing online. Students may register at www.actstudent.org. ACT offers fee waivers for students meeting certain financial criteria.

Student Records/Transcripts

Veterans High School maintains records for students currently enrolled, and records are housed for three years after graduation. Written parent permission or a signature of an 18-year-old is required for release of a student's record, and these may be requested through the counseling office. Students or parents may also request transcripts for universities, colleges, or other related programs. Students can request that transcripts be sent electronically through their Georgia Futures account.

Title IX

Title IX of the Education Amendments Act of 1972 prohibits discrimination on the basis of sex in educational programs or activities. Any inquiries concerning Title IX should be directed to the administration.

Visitors

All conferences with teachers should be arranged through the counseling office; conferences will be scheduled either before school or after school. Visitors are not allowed to go directly to any classroom without prior approval. Any visitor should report to the main office where a visitor's pass will be issued. All visitors must wear badges while in the building. Upon departure, badges should be returned to the main office. Students are not permitted to invite visitors during the school year.

Voter Registration

Students who are 18 years of age may register to vote in the Media Center.

Withdrawal

A parent/guardian must come to the school to withdraw a student. All books and the student's school issued Chromebook must be returned and fines cleared before completing the withdrawal process. Records will not be released to a new school unless the receiving school has sent an official request for records.
