## **Legislative Update**

An interested candidate is required to submit a statement of candidacy to the Williamsburg County Voter Registration and Election Board.

She concluded her report by acknowledging schools for excelling on meeting and exceeding assessment goals.

# Presentation from the Kingstree - Lake City Chapter of Sigma Gamma Rho Sorority, Inc.

Janie McCrea, Basileus, and members of Sigma Gamma Rho Sorority, Inc. presented Kingstree Middle Magnetic School of the Arts, Hemingway M.B. Lee Middle School, and CE Murray Middle School with school supplies. Also, the organization provided art supplies to the middle school art teachers.

#### **Acknowledgement of Academic Achievement**

Dr. Davis, Executive Director of Public Relations, recognized eleven scholars for their exemplary academic success. # Second Reading of Policy "Gavin's Law"

M. Cannion, chair, read Gavin's Law (S.C. Code Ann. Section 16-15-430) in its entirety. The law adopted by the board to be submitted to the State Department of Education for approval and placed on the school district website.

#### **Board Items**

M. Cannion shared First Steps Act 81 and accepted the recommendation of Dr. Wymbs to appoint Ruby Faison to Williamsburg County First Steps Board. A motion was made to accept the recommendation for the First Steps Board by Dr. Gamble seconded by Rev. Dicks. The motion was carried.

M. Cannion updated the board on a meeting she attended along with H. Baker that was held on Thursday, January 18, 2024, in Columbia with members of Williamsburg County Legislative Delegation to include Senator Sabb, Rep. Kirby and Rep. Atkinson. She stated that the delegation is in full support of the board regaining local control of the school district. Also, M. Cannion informed the board of an upcoming meeting with Superintendent Weaver to be held on Wednesday, January 31, 2024. This meeting was arranged by Melvin Stroble, President, SC School Board Association Black Caucus and confirmed by the Superintendent's Office. She stated the following persons were asked to attend by the superintendent's office regarding the status of the takeover: board chair, H. Baker, Senator Sabb, and Melvin Stroble. A report of the meeting will be shared with the board.

Members of the board expressed concerns about needed improvements at Hemingway High School to include paving of parking lot, gym floor, and stage curtains. It was stated for all board members to have the opportunity to shake the hands of all students being recognized at future board meetings. Also, board members thanked Dr. Wymbs and district staff for the progress made in the school district, encouraged students to continue to excel, thanked parents for their attendance and support of their students, acknowledge classmates of students who were recognized at the board meeting, thanked members from Lake City Chapter of Sigma Gamma Rho Sorority, Inc. for their donations, thanked Kingstree High School Choir under the direction of Ms. English for an outstanding performance at the NAACP Laying of the Wreath Program, acknowledged Miracle Cooper and Diamond Swinton for the leadership with the NAACP and thanked Dr. Wymbs for the pavement of Hemingway High School parking lot.

Dr. Wymbs continued to thank his staff for their dedication and commitment to serving our scholars and recognized students for their continued growth and achievements.
