Seconded by M. Burgess. There was a vote by show of hands 8 to 1. Motion carried.

Dr. J. Dicks made a motion that the Board authorize C. Isreal, board chair, to issue a public statement on the Board's behalf regarding the selection of Dr. Lamont Moore as the next Superintendent of the Williamsburg County School District. Seconded by Dr. J. Gamble. There was a vote by show of hands 8 to 1. Motion carried.
