## Superintendent's Comments:

Mr. Henson polled the Board for date and time options to bring in state representatives to give the pros and cons of IE2 and Charter Schools. Mr. Henson reminded members Fannin County had to make a decision the first of 2013 to determine in June 2015 which direction the system would go – status quo, IE2, or a Charter system. The census was to have the presentation on Tuesday, May 8, after the work session.

Mr. Henson presented the Board with a card from Blue Ridge Elementary school thanking members for their service.

Mr. Henson congratulated Austin Vest for recognition by the Georgia House of Representatives on February 22, 2012 for being elected the National Vice President of TSA.

Mr. Henson stated the Georgia Department of Education released the 2010-2011 Georgia high school graduation rates and Fannin County's rate was 82.18%. Mr. Henson also stated the state average was 67.4%. Mr. Henson stated Georgia used the newly implemented four-year adjusted cohort graduation federal formula to calculate these percentages. Mr. Henson stated Fannin County ranked  $22^{nd}$  out of 186 school systems.

Mr. Henson invited everyone to attend the Trout-in-the-classroom release at Tammen Park in Blue Ridge, Georgia, on Friday, May 4, 2012, at 10:00 a.m.

Mr. Henson thanked the Board for the opportunity to serve as Superintendent the past five years.

Mr. Henson recognized the Fannin Leadership participants who were present for the meeting. Mr. Henson pointed out Mr. DeWeese, central office staff, and he had all completed the class and found the information presented to be valuable.

Board Members' Comments:

Steve Stanley stated the items approved at tonight's meeting gave good examples of what SPLOST funds can do for a school system. Mr. Stanley stated he was proud of the graduation rates that had been released.

Bobby Bearden stated he appreciated everyone coming out for the meeting. Mr. Bearden thanked Mr. Henson for the outstanding job he had done as Superintendent for Fannin County Schools the past five years. Mr. Bearden stated he enjoyed being able to serve on the Board. Mr. Bearden also thanked Benny Long, Transportation & Safety Director, along with the bus drivers for the excellent job they did for the students. Mr. Bearden stated an 11 year old had passed away earlier in the day that had been run over.

Terry Bramlett stated he supported Bobby Bearden in congratulating Mark Henson for a job well done. Mr. Bramlett stated he appreciated how Mr. Henson ran the school system including being fiscally responsible with his decisions. Mr. Bramlett also stated safety of students was the top priority and ranked above achievement and learning. Mr. Bramlett thanked Fannin County Farm Bureau for their donation for the Fannin County Middle School FFA greenhouse.

Lewis DeWeese welcomed all of the visitors to the meeting. Mr. DeWeese said it was special to have everyone present.

Sandra Mercier stated she was proud of the technology department and their accomplishments of being progressive in their strategy. Mrs. Mercier stated she had seen technology department evolve from an old school bus, to a broom closet, to its present location in the stand-alone technology building. Mrs. Mercier stated you can either embrace technology or you can run from it, and in education you have to embrace it. Mrs. Mercier stated she was proud of the work Mark Henson does for Fannin County Schools.

There being no further business to come before the meeting, upon motion duly made, seconded, and carried, the meeting adjourned subject to being called into special session by the Chair when deemed necessary.
