Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The plan was developed after consulting with parents, teachers and other school staff. Parent and staff feedback and input was done through surveys given out during February and March 2021. Survey questions included questions on how to support and hlep students loss of instruction in the classroom. SCJUSD staff discussed actions of services to assist students in the loss of instruction due to COVID-19 shutdown. Based upon this input, the following supplemental instruction and support stratagies were determined as needs for students both accademically and social emotional.

- 1. Remediation courses in English and Mathematics for highschool students.
- 2. Increase school based counseling for all students, in particular grades 4-12.
- 3. Staff training staff in new instructional stratagies, including trama-informed practices, to engage and address student-social-emotional and accademic needs.
- 4. Summer intervention program will be offered to students who qualify for extra instruction/support.
- 5. Increase hours for 2021-22 school year for SPARK employees to be used in the classrooms at ECE and IVE.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified throught the 2020-21 school year through classrooms assessments, district benchmarks assessments, teacher observation and CAASPP scores. Students identified below grade level proficiency in ELA and math will recieve additional intervention support including summer school. This support will continue through the 2021-22 school year.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Communication is sent out regularly informing parents of learning opportunities will continue through the 2021-22 school year. This communication includes twice yearly parent/teacher meetings in grades K-8 and the SPARK afterschool program. Highschool students accademics are monitored by both the accademic guidance counselor and administrator. Afterschool tutoring is held twice per week on Tuesday and Thursday. Meetings with parnets on as needed basis to discuss student accademics are a held as needed. Student Study Teams or SST teams discuss student needs and assist the teacher with stratagies to assist students. in which parents are invited and encouraged to participate in these meetings.

Additional staff hours will increase for the 2021-22 school year to better support teacher instruction and students in classrooms. Both the SPARK afterschool instructors, who are regularly part time employees, will be offered 8 hour full time postitions to assist mitigate learning loss. One of the SPARK instructors will be at IVE and the other at ECE school. This will allow elementary school classrooms to have aide support for the majority of the day. These two employees will continue to provide support afterschool in the SPARK program in grades K-8 and at both IVE and ECE schools.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]). The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
