Items for Information and Discussion

A. NMHS Updates

1. NMHS Woodshop HVAC

An RFP for construction has been posted. A mandatory site visit will be held on 9/15 and bids will be opened on 9/29.

2. Roof Project

Roofing contractor Greenwood Industries has completed the standing metal seam and low sloped roof work at the high school. No plan for the potential addition of fasteners and clips has been presented as of this writing.

3. Gym Ceilings

The large gym ceiling at the high school has been completed. In addition, the floor was recoated. Currently work is underway to finish the painting of the small gym with an anticipated completion date of 9/22.

4.Belfor Restorations

Currently Belfor is working seven days a week to finish the installation of casework and countertops in the science wings at the high school. The project should be completed in the month of September.

B. Central Offices

Facilities met with the Town Personnel Director and Building Inspector to discuss ADA accessibility and the proposed doors at Sarah Noble which will separate the school classrooms from the Board of Education offices. A pathway to compliance was established and quotes from contractors are being received for the installation of the two sets of doors.

We have contracted with Silver Petrucelli & Associates to conduct some programming in order to present the Town with some of our needs for a potential stand alone Central Office building.

C. Donation

Kimberly-Clark will be donating 700 boxes of tissues to the New Milford Public Schools. We pick them up on 9/25.
